

## Privacy Policy

**Canon Medical Informatics Inc. (“CMI”, “we” or “us”), a Canon Group company, shares your concerns regarding internet privacy. We think you should know how we will treat the information that we receive offline or on the internet and have created this statement of our policy to demonstrate our continued commitment to privacy by informing you of our practices with respect to your personal data. Please read this privacy policy carefully before accessing or using vitalimages.com (the “Site”).**

### What Information We Collect

- **Information from Site Visitors**

When users request pages on our Site, our servers automatically log their IP addresses. An IP address is a number that is automatically assigned to your computer whenever you are surfing the Web. IP addresses are only used for troubleshooting security issues like hacking attempts and denial of service attacks.

We may also ask to store cookies on your device when you visit our Site. A cookie is a small piece of data (text file) that a website – when visited by a user – asks your browser to store on your device in order to remember information about you, such as your language preference or login information. Those cookies are set by us and called first-party cookies. We also use third-party cookies – which are cookies from a domain different than the domain of the website you are visiting – for our advertising and marketing efforts, and other legitimate business purposes.

- **Personal Data**

Our Site also offers the opportunity for you to obtain information tailored to your specific needs, or general information about our products and services. To respond, we obtain your consent when you provide your name, address, or similar information so we may process your request. At the time you provide this information, we will tell you how it will be used and why.

Emails sent to you for marketing purposes will contain an “unsubscribe” link at the bottom so that you can stop receiving emails at any time.

- CMI may use the personal data collected from you in the following ways:
  - to provide access to our services and customer support, and to process and respond to your inquiries;
  - to record and track your information as requested by you through MyVitrear;
  - to prevent, detect, and investigate misuse of the services or breaches of CMI's terms of use, this privacy policy, or other agreement that you enter into with us;
  - to analyze the effectiveness, usability, or other aspects of the services and the Site;
  - to generate and review reports and data about usage of the services and the Site;
  - to compile aggregate data for internal and external business purposes;
  - to resolve disputes and troubleshoot problems;
  - to contact you with information that may be of interest to you, including promotional, marketing and advertising information;
  - to comply with legal obligations, including, but not limited to uses that are necessary or appropriate to protect ourselves, you, and others;
  - to conduct any other legitimate business activities not otherwise prohibited by law; and/or
  - to take any other action as otherwise stated in this privacy policy;to understand what content is most relevant to you so that we can provide a more personalized experience.

- **Information CMI Does Not Collect**

CMI does not intentionally collect sensitive personal data such as social security number, ethnicity, genetic data, health information, or religious affiliation on the vitalimages.com website. For more information about the MyVitrear website, please see the MyVitrear Website section below.

### **How We Share Your Information**

CMI only discloses personal data to those of its employees, contractors and affiliated organizations that need to process it on CMI's behalf or to provide services available on the Site which have been requested or consented to by the owner of such personal data. Otherwise, CMI does not share personal data with anyone and will only disclose personal data if legally required to do so or if CMI believes that such disclosure is necessary to protect its rights or rights of third parties or the public. Personal data may also be shared in the context of a merger, acquisition, or other transaction in which we combine with or are acquired by another company.

### **Data Retention and Deletion**

CMI may retain your personal data for certain periods of time for specific purposes to the extent that we are obligated to do so in accordance with applicable laws and regulations, to protect you, other people, and ourselves from fraud, abuse, unauthorized access, as necessary to protect our legal rights, or for certain business requirements.

### **Third Party Websites**

### **Use of Cookies, Tracking Technologies and Do Not Track**

CMI may store some information on your computer in the form of a "cookie" or similar file to help us maintain and improve this Site in many ways. As discussed above, a "cookie" is a small amount of data that is transferred to your browser by a Web server and can only be read by the server that gave it to you. On our Site, these cookies function as your identification card, recording such things as internet addresses, passwords, and preferences. The cookies that we use on our Site cannot be executed as code or deliver viruses. With most internet browsers, you can erase "cookies" from your computer hard drive, block all "cookies," or receive a warning before a "cookie" is stored. ### **Legal Basis for Processing**

CMI may process your personal data for the following reasons:

**Performance of a contract.** The use of your information may be necessary to fulfil the contract that you entered into with us. For example, if you use our Site to submit your information to access your images through MyVitrea, we will use your information to carry out our obligation to complete and administer that request or registration under the contract that we have with you.

**Legitimate interests.** We may use your information for our legitimate interests, such as to provide you with the best suitable content of the Site, emails and newsletters, to improve and promote our products and services and Site content, and for administrative, security, fraud detection and legal purposes.

**Consent.** We may rely on your consent to use your personal data for certain direct marketing purposes. You may withdraw your consent at any time by contacting us at the addresses at the end of this privacy policy.

### **U.S. Operation and International Transfer of Information**

The Site is hosted in the United States and information we collect will be stored and processed in the United States. You should be aware that the privacy laws in the United States may not be as protective as those in your home authority. Your agreement to the terms of this privacy policy and submission of information to us represents your acknowledgement and agreement for your information to be processed in the United States subject to United States laws. In addition, our employees, contractors, and affiliated organizations that process information for us as described above may be located in the United States or in other countries outside of your home country; by using the Site, you consent to the international transfer of such information by CMI to such parties.
